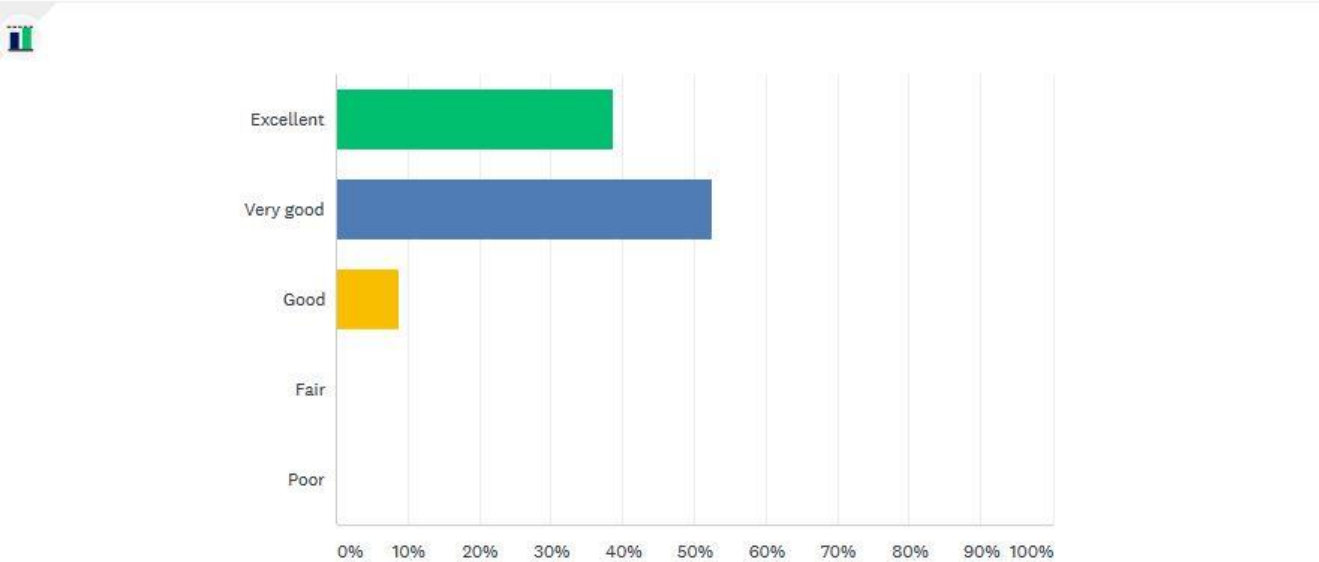

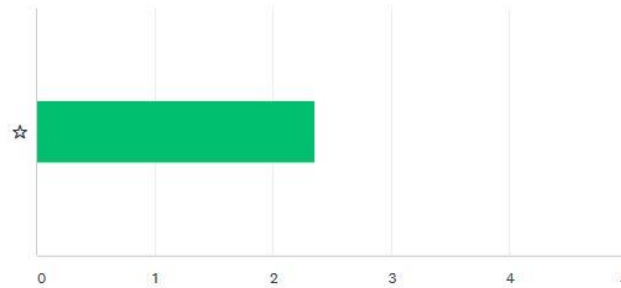
How likely is it that you would recommend MDGFOA to a friend or colleague?

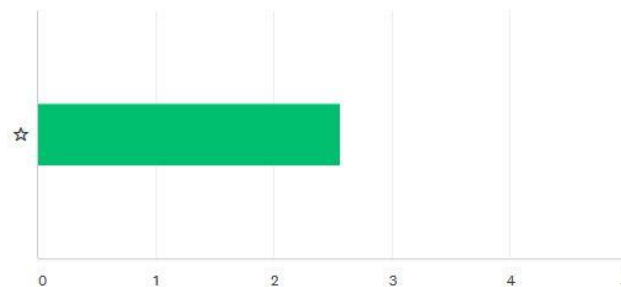

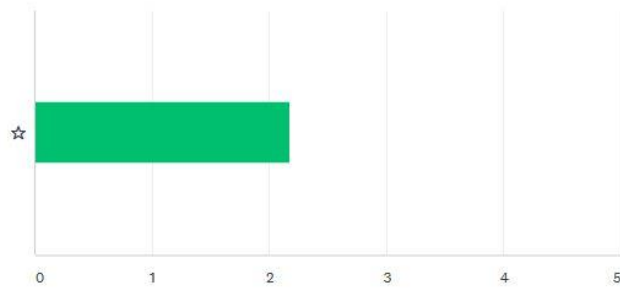

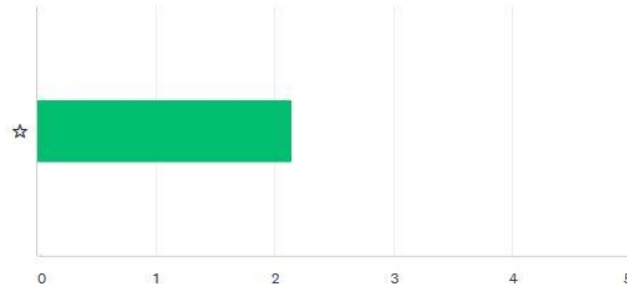

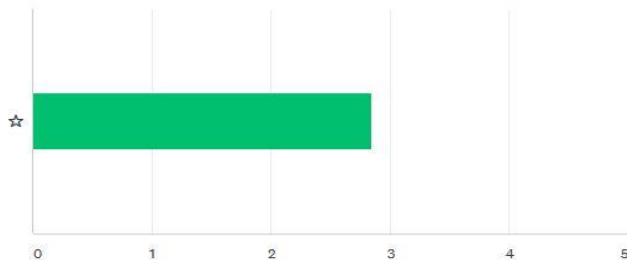
