- Financial Position
  - Cash Position \$190K;
  - No outstanding liabilities of any sort; \$203K of total equity (about 102% of our annual budget)
- Statement of Activity
  - \$119K in total revenue
  - \$63K in total expenditures
  - Shout out to sponsors and partners for providing
  - \$53K in net revenue to date
  - Bad Debt write off of prior year sponsorships (spring and summer sponsorships from prior year when conferences went virtual)
- Budget to Actual
  - Targets for member dues and conference revenues
  - Sponsorship revenues are up
  - Less spending on conference expenses
  - Favorable/Unfavorable (Bill Early) to change the headers
  - $\circ$   $\;$  Inventory shrinkage write off of prior year directories that no longer had value
- Other discussions
  - We many want to have a discussion on rate for the summer conference due to good financial standing. How to return value to membership over the next year
  - Will we need to pay Clarion for any fees for the conference that will not occur? At this time, per Joe Beach, we have not heard from Clarion as the alternate dates that they proposed did not work for MD GFOA.
  - Idea from Dawn Parks Past President dinner; this was done years ago and was well attended. Was done when there were higher reserves at the time.
  - Per Robert Sandlass, T Rowe price account that we still have (Lenny, Jason and Linda Watts are still on it.) This needs to be cleared up (\$54K in the account)
